### Individual Tax Credits

- Individuals can redirect their Georgia state tax dollars to support education.
- Individuals are eligible to receive 100% dollar-for-dollar tax credit when they participate.
- Designate those tax dollars to support St Peter Claver Catholic School's successful model of urban Catholic education.

### Business/Corporate Tax Credits

- Each Member of LLP's/Partnerships and other pass-through entities can redirect up to \$10,000 of their Georgia state tax dollars to support education.
- Each member of the pass-through entity is eligible to receive 100% dollar-for-dollar tax credit when they participate.
- Corporations can redirect up to 75% of their Georgia state tax dollars and receive the same 100% dollar-for-dollar tax credit for participation.
- Designate those tax dollars to support St Peter Claver Catholic School's successful model of urban Catholic education.

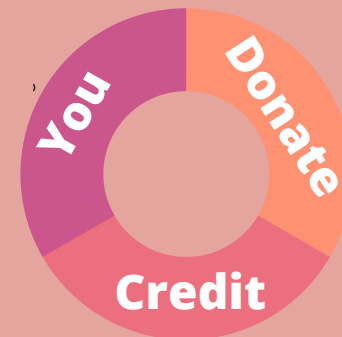

## Tax Credit Program for Individuals and Corporations

The Georgia School Scholarship Tax Credit Program is a unique way for individuals and corporations and small businesses to support St. Peter Claver Catholic School through GRACE Scholars, Inc.

### TAX CREDIT AND HOW IT WORKS:

- Individuals can receive up to \$2,500 in a dollar-for-dollar (100%) tax credit for their contributions to St. Peter Claver's School Scholarship Organization (GRACE Scholars, Inc.)
- Small businesses can receive up to \$10,000 in tax credits; and corporations up to 75% of their Georgia State tax liability in credit for participation.

### THE PROCESS AND WHAT TO EXPECT:

- It is very simple to sign up to participate and takes about 5 minutes online. Once an individual, small business or corporation decides to participate, Regina Sweeney can connect with them.
- Regina can meet with you virtually or in person to walk you through the process in about 15 minutes.
